LETTER FROM THE CITIZENS CLEAN ELECTIONS COMMISSION

Dear Arizona Voter:

The Arizona Presidential Preference Election is on **March 19, 2024**

This Guide is created by Clean Elections, the state's nonpartisan voter education agency, to provide voters official voting information about the Presidential Preference Election (PPE).

The PPE is a unique election that occurs once every four years. It is our state's method of identifying Arizona's preferred presidential candidates. The PPE is NOT a primary election. This is an important distinction as independent voters cannot vote in the March 2024 PPE, but independent voters can vote in the July 2024 primary. Please read through this guide for more information on the PPE and who is eligible to vote.

ABOUT THE PRESIDENTIAL PREFERENCE ELECTION

What is a PPE?

The Presidential Preference Election (PPE), is an election in which voters can choose who they would like to be their presidential candidate in the upcoming 2024 General Election.

Some states have a similar process but utilize different terminology, like a presidential primary, a presidential preference primary or many other variations. Other states hold caucuses in the months leading up to a presidential election. Caucuses are meetings organized by the recognized political parties that are conducted at the county, district, or precinct level. Depending on state and political party rules, presidential primaries and caucuses can be "closed", "open", or a hybrid of the two.

Arizona holds a presidential preference election in March of presidential election years, per state law (Arizona Revised Statutes, Title 16, Chapter 2, Article 4). State recognized political parties have the option of participating in the PPE and having their party's PPE candidates appear on the ballot.

Which parties are participating in the March 19th PPE?

The Democratic and Republican political parties have opted in to participating in the PPE. This means there will be two ballots in the election: a Democratic ballot and a Republican ballot. Each ballot will contain the corresponding party candidates that qualified to have their name appear on the ballot.

Who can vote in the March 19th PPE?

Only voters registered with the participating parties can vote in the PPE. The Democratic & Republican Parties are the only ones participating in the PPE.

This means **only voters registered as Democrats or Republicans can vote in the March 19th PPE.**



ABOUT THE PRESIDENTIAL PREFERENCE ELECTION

Can voters registered with the Libertarian Party, Green Party, No Labels Party, and unaffiliated (Independents), vote in the PPE?

No. Only voters registered with the Democratic and Republican parties may vote in the March 19th PPE.

Why can't unaffiliated/independent voters vote in the PPE?

It's important to note that a Presidential Preference Election is NOT a primary election. Arizona has an open primary law, meaning unaffiliated/independent voters can vote in the July primary election. However, the open primary law does not apply to presidential preference elections.

In 1999, the Arizona Attorney's Office opined:

"Based on the specific language of the open primary provision of the Arizona Constitution and the statutes that implement it, as well as standard rules of statutory construction, the open primary provision does not extend to presidential preference elections."

"The presidential preference election is not denominated a "primary" election and, in fact, it differs significantly from a primary election. Unlike a primary election, the presidential preference election does not determine which candidate is placed on the general election ballot, nor do all parties that will have candidates on the general election ballot participate in Arizona's presidential preference election."

When can independent voters vote in 2024?

There are three statewide elections in 2024. Below describes who may vote in each election.

March 19th PPE: ONLY **Democratic** and **Republican** Voters

July 30th Primary Election: All registered voters, including independents

November 5th Presidential Election: All registered voters, including independents

VOTER REGISTRATION

Voters must be registered by Tuesday, February 20, 2024 as either a Democrat or a Republican to vote in the Presidential Preference Election. Not sure if you're already registered? Check online at azcleaselections.gov/am-i-registered-to-vote.

Ways to Register

Online:

Visit servicearizona.com. You must have a valid Arizona driver's license or identification card to use this service. You will be emailed a confirmation after you complete the registration process.

Paper Form:

Voter registration forms are available at county recorder offices, motor vehicle division (MVD) offices, most libraries, city clerk offices and public assistance agencies.

To download a paper form, please visit: azcleaselections.gov/register-to-vote

Voter Registration Card:

Your county recorder will mail you a voter registration card 4-6 weeks after you register. Voters are encouraged to verify that the information on their card is correct. Please contact your county recorder with any questions, or to request a replacement registration card. Your registration card may be used as a form of ID at the polls.

Qualifications to Register to Vote:

- A citizen of the United States
- A resident of Arizona and the county listed on your registration 29 days prior to the election
- 18 years of age or older on or before the next general election
- You are able to write your name or make your mark (unless prevented by disability)

You are Unable to Register to Vote:

- You have been adjudicated an incapacitated person.
- You have been convicted of a treason or a felony, unless you have had your civil rights restored.

Note: For a first-time felony conviction, civil rights are automatically restored upon completion of a person's sentence and payment of any fines and restitution.

HOW TO VOTE

Vote Early by Mail

Ballots will go out in the mail on February 21st to registered Democratic and Republican voters that are:

- On the Active Early Voting List (AEVL)
- Have requested a one-time early ballot

Voters can mail their voted ballots back by March 12th or drop them off at:

- Designated ballot drop boxes (if available)
- Any early voting location in their county
- Any voting location on Election Day in their county (you do not need to wait in line)

Voted ballots must be received no later than 7:00 p.m. on March 19, 2024 (Election Day).

Vote Early in Person

- Voters may vote early in person at the County Elections Office or at any early voting site in their county.
- Early Voting will begin on February 21st.
- Voters must bring their ID.

Vote on Election Day

- All voting locations will be open from 6:00 a.m. to 7:00 p.m. on Election Day.
- Visit <https://www.azcleanelections.gov/voter-dashboard> to find your voting location.
- Voters must bring their ID.

VOTER ASSISTANCE

Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA)

The Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) ensures that U.S. citizens who are service members, their eligible family members or overseas citizens can vote in their home states. Ballots go out to UOCAVA voters 45 days before the election. If you have a loved one serving or is overseas, please share this guide with them.

Voters with a Disability

The Help America Vote Act (HAVA) requires every polling place to be accessible and have available (and set up for use) accessible voting equipment that may be used by any voter. Additional assistance may be available, such as curbside voting, braille and large print ballots. Voters may also request a special election board visit their residence if they are unable to vote at a voting location due to a physical disability or confining illness. Voters can contact their County Elections Office for additional information.

ID at the Polls

List #1 Sufficient photo ID including name and address (One Required)

- Valid Arizona driver license
- Valid Arizona non-operating identification card
- Tribal enrollment card or other form of tribal identification
- Valid United States federal, state or local government issued identification

List #2 Sufficient ID without a photo that bears the name and address (Two Required)

- Utility bill of the elector that is dated within 90 days of the date of the election
- A utility bill may be for electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television
- Bank or credit union statement that is dated within 90 days of the date of the election
- Valid Arizona Vehicle Registration
- Indian census card
- Property tax statement of the elector's residence
- Tribal enrollment card or other form of tribal identification
- Arizona vehicle insurance card
- Recorder's Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked "Official Election Material"

List #3 Mix & Match from Lists #1 & #2 (Two Required)

- U.S. Passport without address and one valid item from List 2
- U.S. Military identification without address and one valid item from List 2
- Any valid photo identification from List 1 in which the address does not reasonably match the precinct register accompanied by a non-photo identification from List 2 in which the address does reasonably match the precinct register

Members of federally recognized tribes are not required to have an address or photo on their identification in order to cast a provisional ballot.

Frequently Asked Questions

If I'm an independent voter, can I change my political affiliation on my voter registration so I can vote in the PPE?

Yes. The voter registration deadline for the PPE is February 20, 2024. Any voter that is a registered with one of the two participating parties by that deadline can vote in the PPE. After the PPE, you can update your voter registration again if you wish to switch back to independent/unaffiliated.

What happens after the PPE?

The state parties will hold their state conventions to determine their delegates. Delegates from all of the states attend the party's national convention, where the party winners of the Arizona PPE are then considered among the other states' nominees. The official party candidate for President of the United States is selected to represent the party nationally, and placed on the general election ballot across the country.

National Conventions Schedule:

Republican National Convention = July 15-18, 2024 @ the Fiserv Forum in Milwaukee, Wisconsin

Democratic National Convention = August 19-22, 2024 @ the United Center in Chicago, Illinois

How are delegates selected?

The process for selecting delegates is prescribed by each party's bylaws. The PPE decides who the delegates vote for at the national convention.

Do the delegates have to vote for the PPE winner?

Delegates must cast their ballot for the candidate who won the PPE in Arizona unless:

- candidate is nominated by the convention
- candidate releases delegate's obligation
- candidate withdraws from the race
- one round of voting has been held without an official nominee being selected
- After one of the above occurs, each delegate is free to vote as he/she chooses

Frequently Asked Questions

Quick Breakdown of the PPE:

- Register to vote by FEB. 20, 2024
- Presidential Preference Election Day is MAR. 19, 2024
- Only Democrats OR Republicans can vote in the PPE.
- Nominees are finalized at their respective party's national conventions
MAY to AUGUST 2024
- General Election Day is NOV. 5, 2024
- PPE - partisan voters select their preferred party candidate
- Primary Election - nothing to do with voting for president
- General Election - vote for president (via presidential electors/electoral college)

What if my candidate drops out of the PPE and I already voted?

Voters may only vote one ballot. There are several security measures in place to ensure only one ballot per eligible voter is tabulated.

Sometimes, candidates may publicly withdraw from the race. If you still have your ballot but selected the withdrawn candidate, you may spoil your ballot and request a new one from the county.

If you already returned your voted ballot, you cannot vote again. Remember, all ballots must be received by 7pm on March 19th (Election Day).

Candidates

Qualified Candidates:

The candidates listed in this guide have qualified for placement on the PPE ballot during the candidate qualifying period. Candidates may be removed from the ballot by submitting a statement of withdrawal or through a court order. If a candidate withdraws after the ballot goes to print, the withdrawn candidate will still appear on the ballot.

To qualify for the PPE ballot, a candidate must submit to the Arizona Secretary of State a nomination paper and notice of candidacy form, and one of the following:

- Presidential Preference Nomination Petitions with a sufficient number of signatures (500 minimum); or
- Certificates of PPE Ballot Qualification from at least two other states.

The candidates in the guide are listed in the same order they will appear on their party's ballot. Ballot order was determined by random draw by the Secretary of State in December 2023.

Biography: Williamson was born and raised in Houston, Texas. Her father was an immigration lawyer and her mother a stay-at-home mom. Politically her parents were liberals, which, according to Williamson, made her “deeply aware of issues of social justice.”

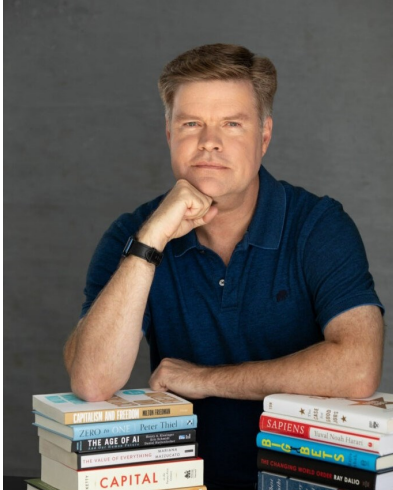
On her 2020 campaign website, Williamson said of her coming-of-age in the sixties and seventies: “From the cultural and spiritual revolution of that time, to the anti-war protests and political activism that marked the era, I was every bit a child of my generation.” She attended Pomona College in Claremont, California for two years before dropping out. She held a series of odd jobs during her twenties, including a cocktail waitress, office temp, and author’s assistant.

Williamson says the book *A Course in Miracles* sparked her interest in religion and spirituality. In 1983, she began giving non-denominational, spiritual lectures based on it. She also began working to halt the AIDS epidemic, creating nonprofits in Los Angeles and New York to provide non-medical support to people living with life-disrupting illnesses. She also founded Project Angel Food, which serves food to homebound people with AIDS in Los Angeles.

Williamson published her first book, *A Return to Love* in 1992. It became a bestseller after it was featured on the “Oprah Winfrey Show.” Williamson has published fourteen more books since then and gained a devoted following that includes several Hollywood celebrities.

In 2004, Williamson co-founded The Peace Alliance, which seeks to “take the work of peace-building and make it a national and international priority through policy and legislation, as well as embodied in our everyday lives.” She ran for Congress in 2014 as an independent in California’s 33rd congressional district. She finished fourth in the blanket primary.

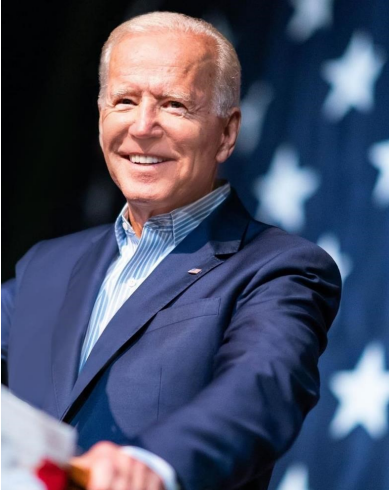

Biography: Joseph Robinette Biden, Jr. was born on November 20, 1942, in Scranton, Pennsylvania. In 1953, the Biden family moved from Pennsylvania to Delaware. Joe Biden graduated from the University of Delaware and Syracuse Law School and served on the New Castle County Council. In 1972, at the age of 29, he was elected to the United States Senate.

Just weeks after the election, tragedy struck the Biden family. Biden's wife, Neillia, and their one-year-old daughter, Naomi, were killed and their two young sons, Joseph "Beau" III and Hunter, critically injured in a car accident. Biden took the Senate oath of office at the hospital and began commuting to Washington every day by train, a practice he maintained throughout his career in the Senate.

In 1977, Biden married Jill Jacobs. Jill Biden, who holds a doctorate (Ed.D.) in Education, has worked as an educator for over two decades. The Bidens raised three children: Beau, Hunter, and Ashley. In 2015, Beau Biden passed away from brain cancer.

As Chairman or Ranking Member of the Senate Judiciary Committee for 17 years, Biden was recognized for his work on criminal justice issues, including the landmark 1994 Crime Act and the Violence Against Women Act. As Chairman or Ranking Member of the Senate Foreign Relations Committee for 12 years, Biden played a pivotal role in shaping U.S. foreign policy. Biden served 36 years in the United States Senate.

In 2008, Barack Obama chose Joe Biden as his running mate. Biden served as Vice President of the United States from 2009 to 2017. As vice president, he implemented the American Recovery and Reinvestment Act, advised President Obama on key foreign policy decisions, led several initiatives to reduce violence against women, and initiated the "Cancer Moonshot" program. On January 12, 2017, President Obama awarded Biden the Presidential Medal of Freedom for his decades of public service.
