## OFFICIAL TITLE

A REFERENDUM ORDERED BY PETITION OF THE PEOPLE ORDERING THE SUBMISSION TO THE PEOPLE OF RESOLUTION NO. R24-131 ENTITLED "A RESOLUTION OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, ARIZONA, AMENDING THE GENERAL PLAN MAP OF THE CITY OF GLENDALE, ARIZONA, BY APPROVING GENERAL PLAN AMENDMENT GPA23-02 FOR PROPERTY LOCATED SOUTH OF CARDINALS WAY BETWEEN 95<sup>TH</sup> AVENUE AND 94<sup>TH</sup> AVENUE."

# **DESCRIPTIVE TITLE**

AMENDING GPA23-03 OF THE GENERAL PLAN MAP OF THE CITY OF GLENDALE, ARIZONA, FROM "PARKS AND OPEN SPACE" TO "CORPORATE COMMERCE CENTER" FOR PROPERTY LOCATED SOUTH OF CARDINALS WAY BETWEEN  $95^{TH}$  AVENUE AND  $94^{TH}$  AVENUE.

A "**YES**" vote shall have the effect of approving Amendment GPA23-03 of the General Plan Map of the City of Glendale, Arizona, as set forth in Resolution No. R24-131, which changes the property land use designation from "Parks and Open Space" to "Corporate Commerce Center" for property located south of Cardinals Way between 95<sup>th</sup> Avenue and 94<sup>th</sup> Avenue.

A **"NO"** vote shall have the effect of denying Amendment GPA23-03 of the General Plan Map of the City of Glendale, Arizona, as set forth in Resolution No. R24-131, and retaining the "Parks and Open Space" property land use designation in the current General Plan Map of the City of Glendale, Arizona, for property located south of Cardinals Way between 95<sup>th</sup> Avenue and 94<sup>th</sup> Avenue.

A REFERENDUM ORDERED BY PETITION OF THE PEOPLE ORDERING THE SUBMISSION TO THE PEOPLE OF ORDINANCE NO. 024-46 ENTITLED "AN ORDINANCE OF THE COUNCIL OF THE CITY OF GLENDALE, MARICOPA COUNTY, AMENDING THE VAI RESORT, CENTERPOINT PLANNED AREA DEVELOPMENT AMENDMENT FOR 66.31 ACRES LOCATED AT THE SOUTHEAST CORNER OF CARDINALS WAY AND THE LOOP 101 FREEWAY; AMENDING THE ZONING MAP; PROVIDING FOR AN EFFECTIVE DATE; AND ORDERING THAT A CERTIFIED COPY OF THIS ORDINANCE IS RECORDED."

## **DESCRIPTIVE TITLE**

AMENDING THE EXISTING CENTERPOINT PLANNED AREA DEVELOPMENT TO CONDITIONALLY REZONE A PARCEL OF LAND IN THE CITY OF GLENDALE, ARIZONA, LOCATED AT THE SOUTHEAST CORNER OF CARDINALS WAY AND THE LOOP 101 FREEWAY SUBJECT TO ZONING REGULATIONS, PERMITTED USES, DEVELOPMENT STANDARDS AND DESIGN GUIDELINES AND AMENDING THE ZONING MAP.

A "**YES**" vote shall have the effect of approving Ordinance No. O24-46 amending the VAI Resort, Centerpoint Planned Area Development (PAD) to conditionally rezone a parcel of land in the City of Glendale, Arizona, located at the southeast corner of Cardinals Way and the Loop 101 Freeway subject to stipulations involving lanes and crosswalks, traffic control, sewer access for pools and water features, dark sky lighting, a signing plan and roadway design, and amending the zoning map to conform to the PAD.

A "NO" vote shall have the effect of denying Ordinance No. O24-46 amending the VAI Resort, Centerpoint Planned Area Development (PAD) to conditionally rezone a parcel of land in the City of Glendale, Arizona, located at the southeast corner of Cardinals Way and the Loop 101 Freeway, disapproving the zoning map changes and retaining the existing Centerpoint PAD.
