There were<br/>5 still questions from the County Recorder's Office at<br/>6 that time, as I understand it, and, moreover, the issue<br/>7 of -- potential issues in the qualifying signatures had<br/>8 been raised on March 15th with the Arizona Secretary of<br/>9 State's Office and myself.<br/>10 To put this in context, the Secretary of<br/>11 State's Office oversees the -- for the most part, you<br/>12 know, the qualification process. It does that by<br/>13 making a determination. That's the words of the<br/>14 Attorney General opinion that's been on the books since<br/>15 2011 -- or 2001, I should say, about whether or not<br/>16 someone is qualified.<br/>17 And so, in this particular case, I think<br/>18 that, you know, a determination does mean that the<br/>19 Secretary of State's Office was in the position to look<br/>20 into this and take actions. We also look to see if the signatures are<br/>8 valid or invalid, and I believe that's all that's<br/>9 required for -- oh, and -- wait -- I believe that's all<br/>10 that's required for Clean Election slips.
