I am filing a complaint against Wendy Garcia who is running as a clean elections candidate. I do not believe she is reporting in good faith her expenses for her AZLD22 State Senate candidacy.

On December 7, 2017 Ms. Garcia had Wendy Garcia for state senate "rally signs" at an Indivisible Surprise event. She did not list any expenses in the 4th Q of 2017 when she announced her candidacy. In addition to rally signs, she also had collection envelopes printed for seed money and \$5s.

Ms. Garcia offered free tickets to the City of Surprise Taste of Surprise to whoever collected the most signatures. If the tickets were free, why didn't she give them to everyone? The Taste of Surprise has a purchase tickets link on their website. Groupon was offering discounts. Isn't offering a gift a form of payment?

Ms. Garcia hosted a event in June on health care at the Unitarian Universalist Church in Surprise. For a past health care event hosted by Indivisible Surprise in March 2017, the church charged \$200 rental fee. <https://www.facebook.com/events/171518286867610/>

Ms. Garcia rented a ramada at Surprise Community Park in June, but it is not listed as an expense.

Most glaring however is her recent campaign finance filing. It does not show a \$700 fine to the SoS for her 2Q 2018 report being a month late as paid. Shouldn't \$14,000 in expenses to one organization be broken down ie. website hosting, sign printing, event expenses such as the

Amada rental to the City of Surprise, flyer printing costs, etc? How do we know the money was spent as designed by the Clean Elections policies?


