This letter serves as an internal complaint against you by the Executive Director of the Arizona Citizens Clean Elections Commission.

Complaint

Recently, the Clean Elections Commission Staff reviewed your original Second Quarter Campaign Finance Report. Exhibit 1. That report indicates that on 5/9/2018, 5/10/2018, and 5/13/2108 you made payments of "backpay" to various vendors in the amounts of \$10,000.00, \$9,300.00, and \$3,000.00 respectively. Exhibit 1, Page 22-23.

Your First Quarter Report, however, stated that you had cash balance of \$2,884.86. Exhibit 2. Based on the original report, had you paid the "backpay" charges at that time, you would not have had sufficient cash on hand to cover the expenses. Ariz. Admin. Code § R2-20-104(D)(6) ("Prior to qualifying for Clean Elections funding, a candidate shall not incur debt, or make an expenditure in excess of the amount of cash on hand."). Further, Section R2-20-110(A)(3) states:

"A candidate may authorize an agent to purchase goods or services on behalf of such candidate, provided that: a. Expenditures shall be reported as of the date that the agent promises, agrees, contracts or otherwise incurs an obligation to pay for the goods or services; b. The candidate shall have sufficient funds in the candidate's campaign account to pay for the amount of such expenditure at the time it is made and all other outstanding obligations of the candidate's campaign committee; and c. Within seven calendar days of the date upon which the amount of the expenditure is known, the candidate shall pay such amount from the candidate's campaign account to the agent who purchases the goods or services.

At a minimum, a review of your campaign finance reports indicates there may be a violation of R2-20-104 and 110(A). In addition, if there was not cash on hand, but an agreement

to provide services was reached, there may have been a violation of A.R.S. §16-941(A); *see also* A.R.S. 16-945. A contribution is "any money, advance, deposit, or other thing of value made to a person for the purpose of influencing an election." A.R.S. 16-901. Here, to the extent that the services were provided, they may be considered an advance or other form of contribution. Please explain why these charges should not be considered contributions in excess of those permitted under the Act, and in the case of First Downs Consulting, from entities you cannot accept contributions from at all.

Additionally, you filed an amended campaign finance report on July 13. This report changed the memo lines for Mary Ann Gass, First Downs Consulting, and Kevin Smith from backpay to different notations omitting the mention of backpay. Exhibit 3. The same day, Commission staff notified a Candidate for Superintendent of Public Instruction named Kathy Hoffman of a similar issue about which a Complaint had been filed. You and Ms. Hoffman share a treasurer. Thus, on the same day Ms. Hoffman and her treasurer were made aware of the Complaint against her, you filed an amended report removing the word "backpay" and providing new explanations for these expenditures. This gives rise to a strong inference that your amended report was designed to avoid detection.

Under the Act, "[i]n addition to any other penalties imposed by law, the civil penalty for a violation by . . . a candidate shall be" \$160 per day up to twice the amount of the expenditure. *Id.* That penalty is doubled if the expenditure is over a certain threshold. *Id.* Additionally, under A.R.S. § 16-941(C), you "continue to be bound by all other applicable election and campaign finance statutes and rules." These requirements, imposed by the Clean Elections Act, include that a campaign finance report include "[a] certification by the committee treasurer, issued under penalty of perjury, that the contents of the report are true and correct." A.R.S. § 16-926(B)(5). Pursuant to A.R.S. 16-956(A)(7) and Ariz. Admin. Code R2-20-704(B) some or all of the Clean Elections Funding you received may be subject to repayment.

Opportunity for Response

Commission rules require notification to be given to the Respondent of a Complaint. Ariz. Admin. Code R2-20-204(A). Additionally, the rules provide that you be advised of compliance procedures. Those procedures are set forth in Article 2 of the Commission's Rules (Arizona Administrative Code Sections R2-20-201 to R2-20-228) as well as the Clean Elections Act (specifically Arizona Revised Statutes §§ 16-940 to 16-961), which are available on the Commission website at www.azcleanelections.gov.

The Commission's rules provide that a Respondent "be afforded an opportunity to demonstrate that no action should be taken on the basis of a complaint by submitting, *within five days from receipt of a written copy of the complaint*, a letter or memorandum setting forth reasons why the Commission should take no action." Ariz. Admin. Code R2-20-205(A). Your response must be notarized, or the Commission will not consider it. Ariz. Admin. Code R2-20-205(C). Generally, a failure to respond to a complaint within five days may be viewed as an admission to the allegations. *Id*.

The purpose of requesting a response is to determine whether you have violated provisions of the Citizens Clean Elections Act or rules and are subject to penalties and repayment under the Act or rules Commission rules require that you be given this notice and Complaint. The issuance of this notice and Complaint do not constitute a finding related to the Complaint. A finding, if any, may be made only after the Commission has reviewed the matter. Mr. Collins:

This letter is in response to the complaint being considered under MUR No. 18-11 against Bill Pierce for three campaign expenditures. In his Second Quarterly report filed on July 3, 2018, which is Exhibit 1 to the complaint, three entries were made containing the word "backpay" in the memo line. This term gave the impression that the committee had been previously indebted to the party indicated, and thus suggested a violation of the Clean Elections Act. For the reasons stated below, there is no reason to believe the Act was violated.

Discussion

The first expenditures was on June 18, 2018, to Mary Ann Gass for \$10,000.00. [Compl. Ex. 1 at 22.] The memo line mistakenly read "Backpay for year of campaign manager services." The Treasurer, Joe Downs submits his affidavit with this response and swears to this Commission that this entry was simply wrong. [Downs Decl. ¶ 3.] He does not understand why he entered this in the memo line, but it was a mistake. Mary Ann Gass submits her affidavit with this response and swears that she initially volunteered for the campaign, but accepted the position as paid campaign manager for the remainder of the primary period. [Gass Decl. ¶ 3-4.] This payment was for work that was to take place, and now after the primary race has finished did take place. The initial entry was simply incorrect.

The next two expenditures were to First Downs Consulting, the firm owned by the Committee's Treasurer, and to Kevin Smith. These payments occurred on June 19 and June 26 for a total of \$12,300. [Compl. Ex. 1 at 22-23.] Both Mr. Downs and Mr. Smith initially provided their services with no expectation of being paid. [Downs Decl. ¶¶ 5-6; Smith Dec. ¶¶ 4-5.] Thus, they provided volunteer services to the Committee and did not view the Committee as unconditionally owing them anything. Their volunteer services to the Committee did not amount to a debt.

At the time Mr. Smith and Mr. Downs provided their services to the campaign, it was not a contribution to the campaign. "The value of an individual's volunteer services or expenses that are provided without compensation or reimbursement" is not a contribution. A.R.S. § 16-911(B)(1). Later paying Mr. Smith and Mr. Downs for their services was a legitimate use of Clean Elections funds. "A participating candidate shall use funds in the candidate's current campaign account to pay for goods and services for direct campaign purposes only." A.A.C R2-20-702(A). Gathering signatures to gain access to the ballot and providing campaign consulting are both direct campaign purposes.

Had Mr. Downs and Mr. Smith never been paid for the services they provided, there would have been no violation of the Act because they are permitted to volunteer their time. Payment after the fact for services that could otherwise have been accepted as volunteer support is not prohibited by the Act.

The use of the term "backpay" created an impression that Mr. Downs and Mr. Smith were *owed* this compensation and that they did not intend to volunteer their services when they were originally rendered. This was a significant and unfortunate error on the part of the Treasurer. However, as you can see from the Declarations made under penalty of perjury and provided in support of this response, the Committee was not indebted to Mr. Downs or Mr. Smith. The reference to "backpay" was a careless error.

For the reasons stated above, the Committee urges you to find that there is no reason to believe that the Act has been violated here.
