I have reviewed the campaign finance reports for the Kiana Sears campaign as well as other materials posted by her or advertisements from her campaign.

There appear to be numerous violations of Clean Elections statutes and rules by Kiana Maria Sears, a Democratic candidate for the Arizona Corporation Commission. I request that her campaign contribution and expense reports show numerous expenditures that need to be thoroughly investigated and audited for compliance with Clean Elections rules and applicable statutes. If there are any violations, I would like the appropriate actions will be taken by the Clean Elections Commission.

Numerous payments were made to her future son-in-law, Sowan Thai. In just one month (March 23 to April 25) Kiana Sears paid her future son-in-law, Sowan Thai, \$8,029.80. \$7,000.00 was for professional services and \$1,029.80 was for reimbursements for expenses. On March 23, 2018, 23 days after receiving her primary funding from Clean Elections Kiana Sears made the first two payments to Mr. Thai, one for \$2,000 and one for \$1,500.00. Another one was made for \$166.00 on March 28, 2018 for a total of \$3,666.00 in thirty days. What was done in that short period of time or to be done? What does her contract with him state and when was it signed? The other payments to Sowan Thai were made on April 16, 2018 (\$2,000.00) and April 23, 2018 (\$1,500.00).

Sowan Thai lives with Kiana Sears' daughter, Elaissia Sears, and Kiana Sears has stated publicly that he is engaged to her daughter. He doesn't appear to have any previous campaign related experience, or videography experience. Both Elaissia Sears and Sowan Thai live together at 925 S. Longmore, #112, Mesa 85202. Elaissia Sears is a candidate for Justice of Peace in the West Mesa Justice Court. Even though Sowan Thai isn't a relative as defined by rule, Elaissia Sears may be benefiting (rent, utilities, internet, cable, food, etc.) from the payment by her mother, Kiana Sears, to her future husband, Sowan Thai.

Another expenditure that needs to be investigated is the \$18,500.00 made on July 14, 2018 to Blue Wave Victory, LLC. This LLC was not approved by the Corporation Commission until July 19, 2018. The members of Blue Wave Victory, LLC are State Representative Reginald Bolding and the Vice Chair of the Arizona Democratic Party, Jevin Hodge. Numerous questions need to be answered: How can a check be issued to an entity that doesn't legally exist? Where and when was the check deposited? Was a contract signed and when was it signed? How was the money spent? Her expenditure report indicates the payment was for List Acquisition, Text Management and Fundraising. However, Ms. Sears purchased VAN access (voter file operated by Arizona Democratic Party) from the Arizona Democratic Party on July 28, 2018. She also paid for VAN access from the Arizona Democratic Party on October 5, 2017. So what lists were acquired by Blue Wave Victory, LLC that she would not have had access to through the VAN? What fundraising was done between July 19 and August 21 by Blue Wave

Victory, LLC on Kiana's behalf? During that time period, only \$1,252 was raised in seed money.

\$1,000 was paid to Marcus Ferrell for District 24 and \$1,693.55 was paid to Navarrette for Senate. Both Marcus Ferrell and Navarette were candidates running for public office. Neither are Clean Election candidates. Is this permissible?

Numerous expenditures for fuel are suspicious and need to be thoroughly investigated. The campaign finance reports just show a dollar amount for gasoline purchased, and the event listed as the cause for the gas doesn't make any sense in terms of mileage to the event, when all of these gas entries on the campaign finance reports are reviewed. There are wide variables in gas mileage claimed for transportation to the purported events. Pursuant to R2-20-702.G2, a travel log with dates, campaign purpose, and mileage is required to be kept by the candidate.

There are number of payments for meals that seem to be inappropriate and also need to be investigated. For example, \$3.77 was spent at a Mesa Burger King on September 27, 2017. Other examples include \$4.31 on June 19, 2017 and \$5.93 on March 12, 2018 at MV Pita Mediterranean in Mesa. Kiana Sears lives in Mesa and the amount appears to be for one person. What campaign event by one person at these restaurants occurred?

Kiana Sears made a television advertisement with her daughter, Elaissa Sears, as was noted above, is running for Justice of Peace in the West Mesa Justice Court. The advertisement touted Elaissa, not just as Kiana's daughter, but also as a candidate for justice of the peace. This advertisement was in addition to many speeches in person that Kiana made touting Elaissia's candidacy for justice of the peace. Elaissia was present when many of these speeches occurred. This advertisement, the speeches and the expenditure for the advertisement may violate Clean Election statutes because they are expenditures using Clean Elections funding to promote a different candidate.

This letter is to notify you that on September 13, 2018, Harry Scott Young filed a complaint against you (copy enclosed) with the Arizona Citizens Clean Elections Commission.

Commission rules provide that upon the filing of a complaint that substantially complies with Arizona Administrative Code Section R2-20-203, notification must be given to each respondent. Ariz. Admin. Code R2-20-204(A). Additionally, the rule provides for an advisement of compliance procedures. Those procedures are set forth in Article 2 of the Commission's Rules (Arizona Administrative Code Sections R2-20-201 to R2-20-228) as well as the Clean Elections Act (specifically Arizona Revised Statutes Section 16-940 to 16-961).

The Commission's rules provide that a respondent "be afforded an opportunity to demonstrate that no action should be taken on the basis of a complaint by submitting, within five days from receipt of a written copy of the complaint, a letter or memorandum setting forth reasons why the Commission should take no action." Ariz. Admin. Code R2-20-205(A). Your response must be notarized, or the Commission will not consider it. Ariz. Admin. Code R2-20-205(C). Failure to respond to this complaint within five days may be viewed as an admission to the allegations. Id. Please provide a response no later than Friday, September 21, 2018.

I, Kiana Maria Sears of Sears for Arizona committee, appreciate the concerns of Mr. Harry Scott Young. I can assure you that no clean elections violations have taken place within campaign committee and I have not used any of the funds inappropriately.

Mr. Thai is a professional videographer and small business owner. My campaign has extensive professional videos including a 4 minute commercial and a video series all listed on my financial report. You can view these videos on my Social Media, Website, and YouTube page. Mr. Thai has also been a super volunteer for the campaign and has also helped by driving me during distant trips such as Bisbee, Douglas, and Flagstaff.

I regularly buy my volunteers (which includes phone bankers or canvassers) a burger or a cheap snack especially in cases where I am giving them a ride to and from the office. As for campaign fuel in my report, I have listed my mileage at a much cheaper expense than calculating by miles. I have driven over 122K campaign miles which is a reimburse cost of over \$53K, I have not reimburse myself at that rate despite incurring over \$8K in vehicle maintain cost which include a new hydrobattery, front & rear brakes, mounts, struts, bushings etc.

Door Knocking (canvassing) is a customary expense in campaigns varying in cost from \$1-\$3 per door. The payments made to Mr. Ferrell and Mr. McFadden were for paid canvassers with a low cost of \$0.50 per piece, Mr. Navarette also help reduced cost by providing a daily proportional rate during the Primary race.



I received emails via my 2 personal and 2 professional facebook pages, I also receive email addresses from my website and four different email addresses. Blue Wave collected email addresses of supporters created unique messages and targeted emails to create a foundation as a base to have an email component of my campaign.

Blue Wave Victory also provided communication services (which included messaging and content creation for my email campaign and a massive text campaign through "Hustle" (a paid service that charges per text).

Sears for Arizona committee has not violated clean election rules 6/26-2018 - IRS EIN LEHER Blue wave invoiced Sears for Arizona for List (Aggregation) Acquisition, Communication Services, 70,000 direct person to person text as well as 50,000 paid calls and a email fundraising based campaign Blue Wave Victory.
