Candidate Debates Work Group members may not discuss items that are not specifically identified on the agenda. Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment will be limited to directing Candidate Debates Work Group staff to study the matter, responding to any criticism, or scheduling the matter for further consideration and decision at a later date.

The Candidate Debates Work Group reserves the right at its discretion to address the agenda matters in an order different than outlined below.
